## **REGULATION FIIC TRENTO 2023 International Festival of Contemporary Engraving**

### **selection announcement**

FIIC - International Festival of Contemporary Engraving of Trento is a festival organized in order to spread the value of modern engraving in all its different forms- both traditional and experimental.

FoyEr organizes the Sixth Edition of the FIIC Prize 2023, entitled "Spectacular". Artworks, selected by a technical commission, will form part of an Exhibition in the foyEr of Trento, in June/July 2023, in conjunction with Fantasio, an International Festival of Theater Direction that achieves this year its 24° Edition.

Among the artworks selected for the exhibition, a Technical Jury will recommend eight artworks, among which the People's Jury, formed by artists, directors and actors participating in the festival, will decide the winner of the Fifth Edition of FIIC 2023.

### **GENERAL RULES OF PARTICIPATION**

**Art. 1** - FoyEr organizes the **Sixth Edition of the FIIC Prize Trento 2023**, that will take place in the foyEr in via Galileo Galilei, 26 (Trento) in June/July 2023.

**Art. 2** - Artists of any age and nationality can enrol.

**Art. 3** - Each participating artist can submit max. two pieces of art. Artworks could have been published. The title of the exhibition is "Spectacular". **Artworks realized before 2022 won't be admitted to the Prize.**

**Art. 4** - Artists are allowed to use **traditional and experimental techniques of engraving** (calcography and/or xylography) which will have a dominant presence of direct intervention of original engraving. For original engraving see what established by the *Milan declaration of original engraving* (1994). Digital print, flat printing (such as lithography and silk screen) and monotype are not admitted.

**Art. 5** - The artworks have to be printed only on **paper with format 350x500 or 500x700 mm** (the sheet can be used in landscape or portrait format); the size of the engraved matrix is free inside the paper.

Artworks outside of these dimensions will not be permitted in the competition.

## REGISTRATION

**Art. 6** - Artists have to submit the **application form no later than 28th February 2023. Registration and participation are free.**

**Art. 7** - Application form at the end of this announcement.

The application form has to be printed, filled in, signed and sent with the original artwork and by email to [fiitrento@gmail.com](mailto:fiitrento@gmail.com) no later than **28th February 2023**.

**Art. 8** - Artists will have to send the original artwork with no frames or passe-partout with the following on the back:

- Name and surname
- Title of the artwork
- Year of creation
- Type of technique
- Name of the workshop where it has been printed

This should be sent to the following address: foyer (c. a. Emilia Bonomi) via G. Galilei n. 26 - 38122 Trento (TN) - Italy. **Original artworks needed to be received, with the filled and signed application form, no later than 28th February 2023.**

The parcel containing the artwork has to have the caption: "STAMPE SENZA VALORE COMMERCIALE" (prints with no commercial value).

All postage and associated insurance costs will be at the expense of the artist.

**Artworks won't be sent back.** The selected prints will remain acquired to the **Mitzi Laner Art Prints Collection** and they will be used and exposed following the most appropriate modality.

## ARTWORKS SELECTION AND AWARD OF PRIZES

**Art. 9** - The Selection Committee, formed by renowned experts from the world of engraving, will select, at its incontestable discretion, artworks that will be part of the Exhibition “Spectacular” and the eight admitted to the Contest of FIIC Trento 2023.

The People’s Jury, formed by artists, actors and theatrical directors, will choose the winner of the FIIC Prize 2023 from the eight finalists recommended by the Technical Jury.

The decision of the Jury is unappealable.

**Art. 10** - To the winner will be organized a personal exhibition during 2023/24 in the foyer. Periods need to be decided upon agreement with the organisation.

**Art. 11** - The result of the selection will be announced by email to the participants and published on the website and facebook profile of the foyer. Catalogue will be sent to selected artists.

**Art. 12** - In order to participate artists need to accept the Terms and Conditions above and consent to the retention of personal data by foyer.

According to art. 13 of DLgs. 196/2003 and to Regulation EU 2016/679, all personal details will be used by the organisation to provide information related to the festival.

**Art. 13** - This regulation has been translated from Italian. Therefore, the original Italian text remains the reference text in case of interpretative doubts.
